Course Description

Introduces object-oriented design and programming via the Java programming language; the use of abstraction, inheritance, polymorphism, composition and interface classes in software design; development of Java applications; study of the Java class libraries, including the Swing tool kit for building human computer interfaces, the network package for development of client-server systems, and the collections' package for data structures and sorting algorithms. Requires a course project. Requires knowledge of C programming.

Course Learning Outcomes

- 1) Apply Object-Oriented Design Principles: Students will be proficient in applying object-oriented design principles using the Java programming language, as well as a honed competency in utilizing inheritance, composition, and interface classes to design robust software solutions.
- 2) Implement Design Patterns and Principles: Students will implement design patterns in Java programming to enhance code maintainability, extensibility, and reusability.
- 3) Utilize Advanced Java Features for Software Development: Students will be proficient in leveraging advanced Java features for software development, such as JavaSwing, and possess skills in GUI programming.
