### Course Description

Introduces object-oriented design and programming via the Java programming language; the use of inheritance, composition, and interface classes in software design; development of Java applications; study of the Java class libraries, including the collection framework classes; recursion, sorting and searching algorithms.

- 3) Utilize Advanced Java Features for Software Development: Students will be proficient in leveraging advanced Java features for software development, such as JavaSwing, and possess skills in GUI programming.
